#### **LOW RISK**

No laboratory-confirmed cases of COVID-19 in the previous 14 days and no reported increase in the number of cases over the last 14 days.

#### **MEDIUM RISK** Low to moderate level of

community transmission.

Minimal amount of laboratory confirmed cases of COVID-19 as determined by community. HCSD schools will be designated as Yellow/Medium Risk Scenario if there are one (1) cases in the city of Hoonah in the previous 14 days with all other cases being classified as

#### **HIGH RISK**

High level of community transmission. Outbreaks or increases in cases and recent laboratory-confirmed cases of COVID-19.

HCSD schools will be closed and will move to the Red/High

Risk Scenario if there have been (1) or more active COVID-19 confirmed cases in the city of Hoonah in the previous 14 days resulting in the designation of a high level of community transmission.

## INSTRUCTIONAL **DELIVERY**

Green Low Risk School Schedule will be based on a "regular" school schedule as much as reasonably possible, with appropriate social distancing.

Flexible scheduling may be utilized for classrooms or grade When students are not meeting levels that cannot provide appropriate social distancing. Needs will attend every day on-site.

Based upon specifications of their individualized education plans (IEP's), special education students may be served outside of their regular times.

All students at home School staff will utilize Canvas, Seesaw, Zoom, Google Classroom, and online electronic learning platforms. Staff will develop regular office hours and class schedules. Based upon specifications of their individualized education plans (IEP's), special education students may be served outside of their regular group time.

### CONDITIONS FOR **LEARNING**

Students, staff, and visitors building will be temperature screened upon entrance and required to wear a mask while in the building. Staff and students will be COVID19 screened twice weekly using the noninvasive saliva test. (Pending receiving the test kits)

No large group gatherings permitted such as assemblies, cafeterias, or field trips. Maintain 6 feet from other people within the hallways, classrooms, and recess areas. Utilization of desk guards in all classrooms with 12 or more students.

Personal protective gear (PPE) masks are required for all staff and students.

Gloves and masks are required for Food and Nutrition Services at all times

Gloves are required for custodial staff and all other staff whenever cleaning or sanitizing custodial staff and all other staff items and surfaces.

Hand sanitizing stations will be made available at the entrance of all buildings and at the entrance of all classrooms and offices.

Breakfast will be grab and go on the way into the school building.
